

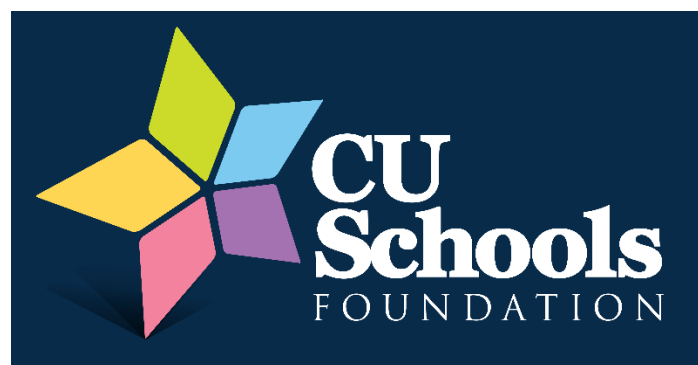

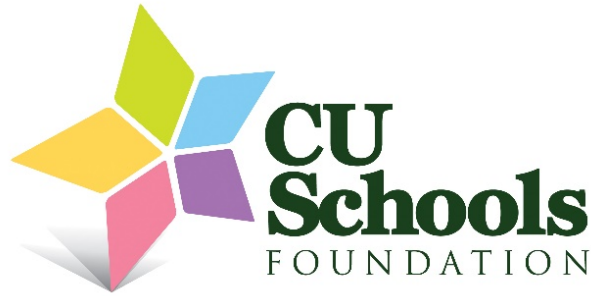

### **Champaign Urbana Schools Foundation Distinguished Alumni Awards Program**

#### **The Purpose of the Awards**

- The Distinguished Alumni Awards shall recognize graduates of the Unit 4 and District 116 high schools, including Champaign Centennial, Champaign Central and Urbana High School, whose achievements, strength of character, and citizenship serve as models to inspire and challenge today's youth.

#### **Conditions of Eligibility**

- The Distinguished Alumni Awards shall be open each year to any alumnus or alumna who graduated from the Unit 4 or District 116 high schools no less than ten (10) years prior to that nomination year. Awards recognize achievement in various fields of service which may include athletics, business, education, entertainment, law, medicine, military, philanthropy, politics, public service, religion, scholarship, science and the fine and performing arts.
- The award must be accepted in person. If the honoree is unable to attend the recognition event, the Selection Committee may select a replacement, and the original nominee will be added back into the pool of candidates for subsequent years.
- No current CUSF Staff, CUSF Board, Review or Selection Committee members (or their immediate families) are eligible for an award.

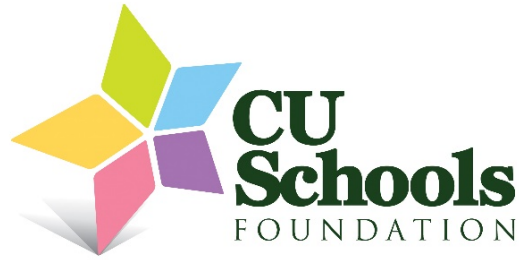
#### **Nomination Procedure**

- Any person other than a member of the Review or Selection Committee may submit nominations for the award.
- Submission of the nomination form, letter of support and vita or resume is expected. All submitted materials should be legible to reviewers, and may be accompanied by photo of the candidate.
- Nominations begin on the day following the most recent recognition event and continue until the announced deadline for the close of new nominations. Nominations received after the announced deadline will be considered candidates for the next recognition event.
- All nomination information will be considered confidential by the Review and Selection Committees.

#### **Review & Selection Procedure**

- A Review Committee shall receive and review all nominations and rank top nominees from each school and award category.
- The Review Committee meets and then presents recommendations to the Selection Committee.
- The Selection Committee; CUSF Board representative, CUSF Ex Director, 1 representative from each high school is charged with determining the final honorees.
- Individuals nominated for the Distinguished Alumni Awards that are not chosen will continue to be eligible for four (4) years following the initial nomination process without re-nomination.

Award recipients will have demonstrated an impact on the community through their commitment to philanthropy, service, and volunteerism, or employing local high school graduates. This award recognizes a local business owner(s) with their business located in Champaign Unit 4 or Urbana District 116 boundaries, who graduated from the Unit 4 or District 116 high schools no less than ten (10) years prior to that nomination year.

- **Employees of the CU Schools Foundation and their family members and individuals serving on the CU Schools Foundation Board of Directors and their family members are not eligible for any of these awards.**
